On behalf of our client, Mr. Gordon Cassar, we are herewith submitting an appeal against the decision taken by the Planning Authority to refuse the application in caption i.e. PA/03643/21.

The reason for refusal by the Planning authority is the following;

The proposed Class 5A car valeting and detailing runs counter to the provisions of Policy SMHO 02 of the South Malta Local Plan. The proposal therefore also runs counter to the SPED Urban Objective 3.5 which aims to protect and enhance the character and amenity of urban areas.

In this regard, our appeal submission is based on the following;

As submitted during the processing of this application (See Annex A\_ Reply to C.O Report\_Existing Commitment), there is already existing commitment with similar use as the proposed within the same garage complex.
