With reference to the refusal given by the PC Board on the 9th January 2017, kindly note that we are appealing the decision given by the same PC Board based upon the following points;

- 1. The Planning Directorate's first reason for refusal is due to the fact that the proposal is incompatible to the urban design and environmental characteristics of the UCA. On the contrary, when the same application has been put forward to the relative external and internal consultants, one should note that:
 - a. SCH did NOT object to the proposal;
 - b. CHAC did NOT object to the proposal, and;
 - The DAC also did NOT object to the proposal.

Therefore one fails to understand how, following the consultation process, the Planning Directorate and Planning Commission still decided to move forward with a negative recommendation/decision without taking on board the consultants' decisions and even more without a single communication with this office for any further information and/or revisions to the proposal. We find this to be completely unjust and unfair on our Client.

2. Furthermore and contrary to reason for refusal no.2 of the same DPA report, we are attaching a montage of the proposal on the existing built development. This to support our argument that the proposed balconies/design is in fact compliant to ALL policies of both the SPED and DC15 documents, and that the overall design of the building respects the characteristics of the area and in fact does NOT negatively impact on the visual integrity of the building and the surrounding Grade 1 properties.
