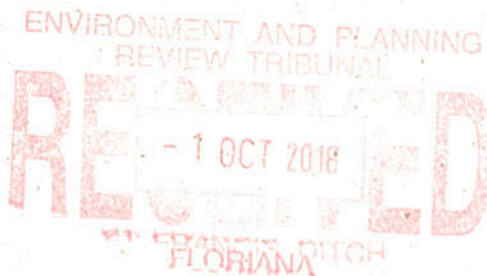
Following the enforcement they are also filing a judicial protest against Giovanni Busuttil.
